**Auditors Report  
To the Members of The Bill & Ben Party**

The Secretary is responsible for the preparation of the Election Expense Form which fairly reflects the electoral spending of the Party during the 2008 election.

**Auditor's Responsibilities**

It is my responsibility to express an independent opinion on the Election Expense Form presented by the Secretary and report my opinion to you. This opinion can only be relied upon by the members of the Bill and Ben Party and the Electoral Commission.

**Basis of Opinion**

An audit includes examining, on a test basis, evidence relevant to the amounts and disclosures in the Election Expense Form. It also includes assessing:

- the significant estimates and judgements made by the Secretary in the preparation of the Election Expense Form, and
- whether the accounting policies are appropriate to the Party's circumstances, consistently applied and adequately disclosed.

I conducted the audit in accordance with New Zealand auditing standards. I planned and performed the audit so as to obtain all the information and explanations which I considered necessary in order to provide me with sufficient evidence to give reasonable assurance that the Election Expense Form is free from material misstatements, whether caused by fraud or error. In forming my opinion I also evaluated the overall adequacy of the presentation of information in the Election Expense Form.

Please let it be noted that I am related to party member Jamie Linehan by blood relationship to the fourth degree. Other than that I have no other relationship or interest in the Party.

**Opinion**

I have obtained all the information and explanations I required and in my opinion the Election Expense Form prepared by the Secretary gives a true and fair view of the Party's electoral spending during the 2008 election.

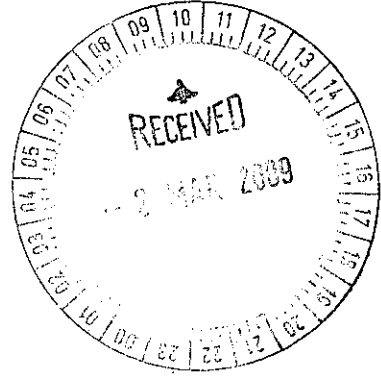
