The attached Party Election Expenses for the 2014 General Election ("the Return") is comprised of parts A to C inclusive and covers the period from 20 June 2014 to 19 September 2014. The Return is prepared in compliance with section 206 of the Electoral Act 1993, and provides information about party election expenses incurred by the Party.

Party Secretary's Responsibilities

The Party Secretary is responsible for ensuring that the Electoral Commission receives a return of the Party's election expenses incurred by the Party for the period 20 June 2014 to 19 September 2014.

Auditor's Responsibilities

Our responsibility is to express an opinion on the Return in terms of the requirements of Section 206 of the Electoral Act 1993, in all material respects. Our engagement has been conducted in accordance with SAE (NZ) 3100 *Compliance Engagements* to provide limited assurance that the Party has complied, in all material respects, with section 206 of the Electoral Act 1993.

Our procedures included examining evidence relevant to the amounts and disclosures in the return. These procedures have been undertaken to form an opinion as to whether the Party has complied in all material respects, with the relevant provisions under the Electoral Act 1993 for the period from 20 June 2014 to 19 September 2014.

Other than in our capacity as reviewer, we have no relationship with, or interests in, the Green Party of Aotearoa New Zealand.

Use of Report

This report was prepared solely the Party Secretary of the Green Party of Aotearoa New Zealand. We disclaim any assumption of responsibility for any reliance on this report for any purpose other than that for which it was prepared.



Basis for Disclaimer of Opinion

Because of the inherent limitations of any election expenses made in certain circumstances and there are no practical assurance procedures to determine the effect of that limited control, it is possible that fraud, error or non-compliance may occur and not be detected. As the procedures performed for this engagement are not performed on a regular basis and performed in respect of the Party's compliance with the relevant provisions made under the Act our assurance engagement cannot be relied upon to detect all instances where the party may not have complied with the Act. The disclaimer of opinion expressed in this report has been formed on the above basis.

Based on the evidence obtained from the procedures we note the following limitations:

- We are not the auditor of the Green Party of Aotearoa New Zealand branches, our scope was therefore limited in respect of assessing the completeness of election expenses which may have been incurred at branch level;
- It is possible that the Green Party of Aotearoa New Zealand may have received public funds for election expenses and our scope if limited in respect of our access to information regarding such expenses;
- Controls over the recording of the election expenses that may have been provided at no cost are limited as there are no assurance practical procedures to determine the effect of this limited control; and
- Difficulties in the apportionment of election expenses of election activity between candidates and the Green Party of Aotearoa New Zealand as a whole.

Disclaimer of Opinion

Because of the significance of the matters described in the Basis of Disclaimer of Opinion paragraphs, we have not been able to obtain sufficient appropriate evidence to provide a basis for an opinion as to whether the details disclosed in the Return for the Green Party of Aotearoa New Zealand, complies, in all material respects, with Section 206 of the Electoral Act 1993 for the period from 20 June 2014 to 19 September 2014.

Other Matters

Per the Electoral Act 1993:

 We found nothing to suggest that proper accounting records were not kept and when questions were put to the client we received all the explanations we required.


