### Notes to the Financial Statements

# Freedoms New Zealand For the 14 months ended 31 March 2024

### 1. Reporting Entity

The reporting entity is Freedoms New Zealand (excluding component political parties) ("Umbrella Party"). The results and balance sheets of component parties have been excluded from these financial statements.

Freedoms New Zealand is an unincorporated organisation, an umbrella political party with component political parties, which exists to pursue political objectives.

The financial statements for Freedoms New Zealand (excluding component political parties) are presented for the 14 months ended 31 March 2024, as the entity was only registered on the 15<sup>th</sup> February 2023.

These financial statements have been approved and were authorised for issue by the Umbrella Party on 29 September 2024.

### **Statement of Compliance and Basis of Preparation**

The accounting principles recognised as appropriate for the measurement and reporting of the Statement of Financial Performance and Statement of Financial Position on a historical cost basis are followed by the entity, unless otherwise stated in the Specific Accounting Policies. All transactions in Financial Statements are reported using the accrual basis of accounting.

The information is presented in New Zealand dollars. All values are rounded to the nearest \$.

The financial statements are prepared under the assumption that Freedoms New Zealand (excluding component political parties) will continue to operate in the foreseeable future.

No comparative figures are shown as this is the first financial year of reporting for this entity.

### **Specific Accounting Policies**

The following specific accounting policies which materially affect the measurement of the Statement of Financial Performance and Statement of Financial Position have been applied;

### **Revenue Recognition**

Revenue is recognised to the extent that it is probable that economic benefits will flow to the taxpayer and the revenue can be reliably measured.

#### **Donations**

Donations are recognised as revenue upon receipt and include donations from the general public, members or donations-in-kind. Donations in-kind include donations received for services and is recognised in revenue and expense where the service or good is received. Donations in-kind are measured at their fair value as at the date of acquisition, ascertained by reference to the expected cost that would be otherwise incurred by the Umbrella Party.



#### **Expenses**

Expenses have been classified on their business nature.

#### **Income Tax**

The Umbrella Party is not subject to income tax pursuant to the Income Tax Act 2007.

#### **Trade Receivables**

Trade Receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less an allowance for any uncollectable amounts. Individual debts that are known to be uncollectable are written off in the period that they are identified.

#### **Good and Services Taxation (GST)**

Revenues and expenses have been recognised in the financial statements exclusive of GST expense that irrecoverable GST input tax has been recognised in association with the expense to which it relates. All items in the Statement of Financial Position are stated exclusive of GST except for receivables and payables which are stated inclusive of GST.

### **Changes in Accounting Policies**

This is the first year reporting for this entity, therefore there are no changes in accounting policies.

### 2. Contingent Liabilities

Freedoms New Zealand (excluding component parties) has no contingent liabilities as at 31 March 2024.

### 3. Capital Commitments

Freedoms New Zealand (excluding component parties) has no capital commitments as at 31 March 2024.
