Breach of the Electoral Act 1993

Summary:

I wish to bring to your attention the following email advertisement, for the Act Party and Act Party candidate which in recent days has been circulated to members of the public. I believe this advertisement has been published in breach of the Electoral Act 1993.

The advertisement is clearly an election advertisement and therefore requires a promotor statement under section 204F of the Electoral Act 1993.

Analysis:

Section 3A of the Act defines *election advertisements* as:

an advertisement in any medium that may reasonably be regarded as encouraging or persuading voters to do either or both of the following:

1. *to vote, or not to vote, for a type of candidate described or indicated by reference to views or positions that are, or are not, held or taken (whether or not the name of the candidate is stated)*
2. *to vote, or not to vote, for a type of party described or indicated by reference to views or positions that are, or are not, held or taken*
3. *a candidate advertisement; and*
4. *a party advertisement*

I submit that this advertisement is (and is intended to be) an election advertisement; it can be *reasonably regarded as encouraging or persuading voters* to support, and vote for, the Act candidate.

For the sake of transparency, election advertisements are required to carry a promotor statement under the Act. This advertisement does not contain a promotor statement.

In addition, as we are in the regulated period, this advertisement may have implications for spending limits. Additionally, 'free' advertising may fall within the category of an election donation to the candidate and the Act Party.

I would ask the Commission to investigate these matters
