OFFICIAL INFORMATION ACT REQUEST 2023/74

On Tuesday, 17 October 2023 you made a request under the Official Information Act 1982 (the OIA) for the following information:

OIA request - who runs the EC social media accounts and advertising strategy?

OIA request - please send me copies of email, and other communication types, instructions to Returning Officers &/or Electoral Managers regarding engagement with scrutineers in the preliminary count of the 2023 General Election. Please include the generic instructions as well as specific instructions to different electorates.

The Electoral Commission's social media accounts are run by the Communications and Education team. The Commission does not have an "advertising strategy", but our Public Information Strategy is developed by the Communications and Education team in consultation with internal and external stakeholders and providers, including the Commission's advertising and research agencies, and is signed off by the Electoral Commission board.

Voting Services communicate to its field staff through the Voting Services regional update newsletter, called Pānui Pōti. Pānui Pōti is a communication channel to inform field staff on what is required for different phases of delivering the General Election, as well as providing general information in relation to updates and reminders of key actions for field staff.

In the newsletter 38 Pānui Pōti, sent on 10 October 2023, regional field staff were informed about a number of master form updates that were uploaded to the intranet system (ECHO) which included 3 links:

- Scrutineer information for Election Day voting place managers M41-Scrutineer
- Updated Early Count bring for scrutineers M55-ECSCR
- Official Count briefing for scrutineers M80-OCSCR

Another newsletter update, 39 Pānui Pōti, was sent on 12 October 2023 to regional field staff, informing them about scrutineers in both early and official counts.



As part of training to field staff, 'Parties and scrutineers' material was presented in September 2023, and 'Scrutineers' material was presented in October 2023.

One information document on security considerations around scrutineers was provided to Voting Services field staff.

Five chapters of the Electoral Commission's Operations Manual include specific guidance on scrutineers. Voting Services field staff are provided with the Operations Manual.

The Personal Instruction Manual (PIM) for Voting Place Managers also contains guidance on scrutineers.

Further, a phone call between Senior Policy Advisor Benjamin Baker and the Hamilton East Electorate headquarters took place regarding the behaviour of a scrutineer.

The Legal and Policy team sent two emails to Hamilton East Electorate headquarters with guidance on scrutineers, including the statutory requirements for observing the issuing of votes and the early count.
