INFORMATION ON CANDIDATE DONATIONS, ELECTION EXPENSES AND LOANS

WHO MUST FILE A RETURN?

All electorate candidates at the 2023 general election must file a return of candidate donations, election expenses and loans. Even if you have no donations, expenses or loans to declare, you **MUST** still complete the candidate return recording 'NIL' donations, expenses and loans.

KEEPING RECORDS OF DONATIONS, EXPENSES AND LOANS

Candidates must keep good records of all candidate donations, candidate expenses and loans. Candidates must keep invoices and receipts for all election expenses of \$50 or more for three years after returns are filed.

DONATIONS Complete Parts A to E

Information on Candidate Donations

Candidates are required to include in the candidate return every candidate donation or contribution to a candidate donation of more than \$1,500 (including GST), including a series of donations or contributions made by one person that adds up to more than \$1,500.

Candidate donations

A candidate donation includes any money, goods or services that are donated to a candidate, or a person on the candidate's behalf, for use in the candidate's campaign for election. The following are candidate donations:

- free goods or services that have a reasonable market value greater than \$300 (or \$50 if provided by an overseas person);
- discounted goods or services where the reasonable market value of the goods or services is greater than \$300 (or \$50 if provided by an overseas person);
 - the difference between the contract or agreed price and the reasonable market value of those goods and services is a donation;
- the purchase of goods or services from the candidate at a value that exceeds their reasonable market value;
 - the difference between the price paid and reasonable market value is a donation;
- extending credit to a candidate on favourable terms;
 - the value of the favourable terms is a donation.

The following are not a candidate donation:

- free labour
- goods or services provided free of charge to a candidate, or to any person on the candidate's behalf, that have a reasonable market value of \$300 or less (or \$50 or less if from an overseas person), or
- money provided by the candidate for his or her own campaign.

Instructions for Part A

For donations of more than \$1,500 (other than anonymous donations or overseas donations) you need to record the name and street address of the donor, the date the donation was received and the amount received from the donor.

Where you have received a number of donations from the same donor you should include each date on which a donation was received from the donor and the aggregated total from the donor. Aggregated donations are not contributions and do not have to be recorded in Part B.

You also need to confirm whether any person (other than the donor) has contributed more than \$1,500 to the donation (or more than \$50 if the contributor is an overseas person). Contributions of more than \$1,500 must be disclosed in Part B (or Part E for contributions of more than \$50 from an overseas person).

Example:

John Smith owns a publishing company. On 1 November 2022 he gives you goods for your campaign valued at \$1,000. On 10 November 2022 he also gives you a monetary donation of \$4,000. The money was given to you as the result of a fundraiser which John Smith organised and includes a contribution from Jane Jones of \$2,000.

An anonymous donation is a donation made in such a way that the candidate who receives the donation does not know the identity of the donor and could not, in the circumstances, reasonably be expected to know the identity of the donor.

If you receive an anonymous candidate donation greater than \$1,500, you may retain \$1,500 of that donation. The balance of the donation must, within 20 working days of receipt, be paid to the Electoral Commission for payment into a Crown bank account.

- the date payment to the Electoral Commission was made; and
- the amount paid to the Electoral Commission.

An overseas person is:

- an individual who resides outside New Zealand and is not a New Zealand citizen or registered elector; or
- a body corporate incorporated outside New Zealand; or
- an unincorporated body that has its head office or principal place of business outside New Zealand.

If you receive a candidate donation from an overseas person exceeding \$50 (including free goods and services or a discount on goods or services exceeding \$50) you may retain \$50 of that donation. The balance of the donation must, within 20 working days of receipt, either be returned to the overseas person who made the

donation, or if this is not possible, be paid to the Electoral Commission. Further guidance is available in the **Candidate Handbook – General Election 2023**.

ELECTION EXPENSES Complete Parts F and G

Your election expenses during the regulated period (14 July to 13 October 2023) must not exceed \$32,600 (including GST). It is an offence to spend more than this.

Information on Candidate Expenses

Candidate election expenses are the costs of advertising in any medium that:

- may reasonably be regarded as encouraging or persuading voters to vote, or not to vote, for an electorate candidate (whether or not the name of the candidate is stated), and
- are published, or continue to be published, during the regulated period for the general election, and
- are promoted by the candidate or with the candidate's authority.

Election expenses include:

- the costs incurred in the preparation, composition, printing, postage and publication of the advertisement, and
- the reasonable market value of any material used or applied towards the advertisement provided to the candidate for free or below reasonable market value.

A candidate's deposit or the costs of hall hire, refreshments, the conduct of surveys or opinion polls, free labour, the framework that supports hoardings (other than a commercial framework) or replacing materials that have been destroyed through no fault of the candidate are not election expenses.

Further guidance is available in the *Candidate Handbook - General Election 2023*.

Instructions on how to complete Part F

You should record all election expenses incurred in relation to candidate advertisements published, or continued to be published, during the regulated period for the general election promoted by you or with your written authority.

For advertisements published both before and during the regulated period you should apportion the costs so that only a fair proportion of the expenses are attributed to being incurred during the regulated period. Only record the amount attributable to the regulated period in the return.

Instructions for Part A

Please find enclosed a corrected Return of Electorate Candidate Donations, Expenses and Loans for the 2023 General Election. This return corrects and replaces the previously filed return, which contained an error.

This error was inadvertent, and I am extremely disappointed in myself for not spotting it. There was no ill intent – I mistakenly thought the return was for 2023 only, and the 2022 donations had already been filed. Clearly, I was incorrect.

I had always intended for these 2022 donations to be made public — indeed I had written to the donors indicating this would happen, and my electorate committee had highlighted most of the donations to the National Party HQ. I am embarrassed this mistake has been made.

I explain in further detail the errors made previously below.

In February 2024 I signed my Return of Electorate Candidates Donations, Expenses and Loans for the 2023 General Election in accordance with my obligations under the Electoral Act 1993.

On the evening of 13 May 2024, I was made aware of a potential error with my return, which was identified by the National Party HQ when reconciling donation returns with electorate accounts as part of the Party's consolidation of accounts. After a clarifying Teams meeting with National Party HQ on 14 May, it became clear that I had indeed made a mistake with my return. The return only included the donations and expenses for the 2023 year and not donations for the entire campaign period. Following this meeting I immediately undertook an investigation and audit process with my team to determine how this error occurred and to rectify it.

As one of the early National Party candidates I began my campaign in October 2022, and began receiving a number of candidate donations in November and December 2022. I intended for these to be made public:

- I wrote to donors indicating that donations over the legislated threshold would be reported publicly.
- Additionally, the electorate team flagged most of these candidate donations with National Party HQ via email in November 2022, and included the consolidated amount of donations, as a liability, in the New Plymouth Electorate Financial Reporting Template for the period ending 31 December 2022 in the electorate's financial accounts. I now realise this is not the proper pathway through which candidate donations are declared.

In November 2023 the New Plymouth Electorate treasurer filed with the National Party HQ the “New Plymouth Electorate Candidate donations and Party donations template returns” following the end of the campaign period. Because of an error in understanding, that return did not contain any donations received in 2022 and only had information relating to the 2023 calendar year. I was not aware of this discrepancy.

The National Party HQ accounting team then populated a Return of Electorate Candidates Donations, Expenses and Loans for the 2023 General Election on my behalf based on the information disclosed to them in November 2023. As a result, that document only contained expenses and donations for the 2023 year.

When I went to sign the return, I incorrectly assumed that the return to be filed in 2024 was only to cover donations and expenses for the 2023 period and that the 2022 expenses and donations had previously been filed with the Electoral Commission by the National Party directly. This was a mistake which I accept and apologise for.

At the time of declaration, I wrongly believed that full disclosure of my candidate donations had been declared to the National Party, and I assumed that the correct process of capturing the amounts needed to be declared in my Candidate Return to the Electoral Commission was followed. I had no intention of not fully disclosing my candidate donations.

I have now, with the assistance of my team, conducted a full audit of my 2022 and 2023 expenses and donations and have provided this corrected return to the Electoral Commission. In the course of this thorough audit process, I also became aware of one 2023 donation which had not been disclosed to National Party HQ and therefore was not included on the 2023 return. I have also rectified this mistake, and it is now included in the return provided.

I trust that this letter explains my error. It was unintentional and it is important to me that the record is corrected.

NON-DISCLOSURE OF DONATIONS IN CANDIDATE RETURN FOR THE 2023 GENERAL ELECTION

Thank you for your letter of 20 May 2024 explaining that you failed to report a number of donations, totalling \$178,394, in your candidate return for the 2023 General Election.

The donations rules and disclosure requirements are set out in Part 6A of the Electoral Act 1993 (the Act). Under the rules a candidate donation is defined broadly as a donation (whether of money or of the equivalent of money or of goods or services or of a combination of those things) that is made to a candidate, or to any person on the candidate's behalf, for use in the candidate's campaign for election. Candidate donations and contributions to donations of more than \$1,500 (including GST) are required to be declared in the candidate's return.

Candidates must keep proper records of all candidate donations. A number of possible offences arise where there has been a failure to comply with the requirements of the Part 6A of the Act. Where the Electoral Commission believes any person has committed an offence in this Part the Commission must refer the matter to the Police unless the Commission considers the offence is so inconsequential that there is no public interest in reporting the matter (section 207O of the Act).

To assist the Commission in considering this matter please respond to the following questions by **5pm Thursday 30 May 2024**:

- How were the donations received and into which account were they paid?
- How were records kept of donations received in November and December 2022 and during 2023 for your campaign, and by whom?
- Why was the donation of \$10,000 received on 19 June 2023 not included in your original return?
- Why has the name of the donor Waume Tilo in your original return changed to Wayne Tuki? What name was held in your records?
- Any other information that you would like the Commission to consider.

You may wish to seek legal advice in preparing your response.

Thank you for your letter of 24 May 2024 setting out further questions the Commission has in relation to my corrected Candidate Return for the 2023 General Election (the **Candidate Return**).

This letter sets out, in sequential order, my responses to those questions. I also attach supporting documentation referred to in this letter as "Attachments". Some of these attachments are in redacted form, to protect the privacy of donors' who made donations that are not required to be disclosed to the Electoral Commission.

1. How were the donations received and into which account were they paid?

I, or a member of my team, communicated with all potential contributors both verbally (through a phone call) and via emails. I would inform potential contributors that if they wished to make a donation/contribution, they could credit donations into my Electoral campaign account (details below), managed by the Electorate Treasurer. In doing so I would also inform the prospective donor that, if their contribution was over \$1,500 (in the case of domestic contributors), in order to comply with my obligations under the Electoral Act I require their name and address so the details of the donation could be disclosed. By way of example, see the email correspondence between a donor, Mr Colin Reynolds, and myself, attached as "A".

All 2022 and most of the 2023 donations were directly credited into TSB account [REDACTED] as shown in the 2023 campaign donations amended return. See TSB bank transactions excel sheet attached as "B".

In April 2023 we made a decision as an Electoral team to switch banks to BNZ. The new campaign account which received donations from that point was BNZ account [REDACTED]. This means that some of the later donations were made to the BNZ account. The Stuart Jones donation (discussed under question 3) was credited into the BNZ Account. See attached the BNZ campaign account transaction history attached as "C".

2. How were records kept of donations received in November and December 2022 and during 2023 for your campaign, and by whom?

As explained above, all donors were communicated with both verbally and via emails. All donors and prospective donors understood the requirement to disclose the contributors name and address, and all donors provided these details via email to myself which were then passed on to the New Plymouth Electorate Treasurer.

Initially, in the first few weeks of my campaign, I personally kept an excel spreadsheet of my 2022 donations until the recording of all donations and reconciling against bank records was set up with the New Plymouth Electorate Treasurer.

The New Plymouth Electorate Treasurer reconciled the bank accounts, including the account that received donations, in Xero. The 2022 Donations received were receipted to a general ledger code in Xero called "200-Donations". See attached the Xero extract titled "Account Transactions code 200-donations" as "D". The names of donors were recorded in Xero. From 1 January 2023 to 30 June 2023 the candidate donations were receipted to a Xero ledger account with the name "808-Non-regulated Campaign Funds", attached as "E". In July 2023, as part of a wider Party led change to a streamlined approach in Xero (discussed under question 5), the Xero account changed again. From that point onwards the Electorate Treasurer used a Xero general ledger account "4004 – Donations received on behalf of a Candidate", attached as "F".

Most records of donations received were disclosed to the National Party. The donation of 19 June 2023 was missed for the reasons discussed below. In November 2022 the Electorate Treasurer disclosed the donations received to date, and donations that were expected to be received (all but one were actually received), via an email to the National Party HQ. See attached the email correspondence as "G". A further update of donations received from 1 January 2023 to 31 May 2023 were sent to the Party on 1 June 2023. Donations received from 1 January 2023 to October 2023 (the end of the campaign period) were disclosed to the Party in November 2023. See attached the email correspondence as "H" and the disclosure as "I" (note that this document is incorrectly titled "Donations Return – PARTY" but in fact records the Candidate Donations, the Party donations were disclosed to the National Party in a separate document). The information provided by the Treasurer to the Party was used by National's HQ to populate a draft Candidate Return, which was then sent to me for my review and signature.

3. Why was the donation of \$10,000 received on 19 June 2023 not included in your original return?

As explained above, the Electorate Treasurer kept the records of all donations for the 2023 campaign (aside from my own record keeping in the first few weeks). I passed on all donor details to the Treasurer, including the donation received on 19 June 2023. See the email correspondence attached as "J". As I had passed the details on, I assumed it would be included in the information given to National HQ to populate my Candidate Return. I was not aware that donation had not been included in the information given to the Party. Once I became aware of the wider issue with the 2023 Candidate Return, I carried out a full audit with my team and consulted the Electorate Treasurer to ascertain how this donation was missed. The following information has been provided to me largely from the Electorate Treasurer and his recollection of events.

In 2023, the National Party asked all electorates to move to Xero to implement a common accounting system and a standardised chart of accounts.

The Party provided the New Plymouth Electorate Treasurer with a new account in Xero for reporting and reconciling donations and expenses. This is called the “4004” account (see Attachment “F”). To set up this new account, the net amount of general ledger Xero Account 808 was cleared and transferred to a common Chart of Accounts (CoA) on 30 June 2023. The Stuart Jones donation was included in this net amount but not included in the information provided to the National Party to populate my return.

The 2023 Candidate Campaign Donations Template (the Draft Candidate Return) was therefore completed by the Electorate Treasurer from two sources, the 1 June 2023 Donations sent to the National Party covering the period 1 January 2023 to 31 May 2023 using the Xero account 808 and from the new Xero account 4004 for the remaining period from 1 July 2023.

The Stuart Jones campaign donations was received on 19 June 2023 and reconciled into the Xero account 808. It was the only donation that was received into the 808 account for the June period (so after the May reporting but before the transfer to the new Xero 4004 account). The donation was reconciled into Xero account Non-Regulated Campaign funds account 808 (which was not used following the wider changes to the accounting processes in June 2023). Unfortunately, when the Treasurer was completing the draft information asked for by the Party in November 2023, he did not refer to the old, closed Xero account 808 as he incorrectly thought that this had been closed as part of the move to a standardised chart of accounts and there were no other transactions coded to this Xero account.

As a result of the above, the populated 2023 Candidate Return from the National Party, which relied on the information sent by the Electorate Treasurer, sent to myself did not include the Stuart Jones donation. I did not pick this up prior to signing my Candidate Return.

4. Why has the name of the donor Waume Tilo in your original return changed to Wayne Tuki?

The name Wayne Tuki was recorded by the Electorate Team correctly. We have never had a donor named “Waume Tilo”, nor do I know of anyone of that name. In the 2023 Candidate Campaign donations template submitted on 26 November 2023 to the National Party the name provided was Wayne Tuki. See Attachment “I”.

It appears that in the 2023 Return of Electorate Candidate Donations, expenses and loans for the 2023 General Election the name was incorrectly populated. The misspelt letters are next to the correct letters on a keyboard. This misspelling was not picked up prior to me signing the Return.

5. Any other information that you would like the Commission to consider.

This was the New Plymouth Electorate Treasurer’s first campaign they were involved with. It was also my first campaign. This campaign period coincided with the enactment of the Electoral Amendment Act requiring enhanced accounting and reporting.

In response to the Amendment Act, as explained above the National Party implemented a new common set of accounts, which created difficulties for my team in reconciling data and completing templates.

The Electorate Treasurer completed the Party donations and Candidate donations templates supplied by National HQ at the same time and incorrectly assumed he only needed to add into the candidate template the candidate donations from the 2023 financial year. The Treasurer's (incorrect) assumption was that the Party had knowledge of most of the 2022 candidate donations and would have therefore populated the Candidate Return to include both the 2023 and 2022 donations accordingly. See the email correspondence in February 2024 (sent after the Candidate Return was filed) between the Party and the Treasurer illustrating this incorrect assumption, attached as "K". The Electorate Treasurer should have picked up the need to complete the template with both the 2022 and 2023 donations based on earlier correspondence in November 2023 with the National Party. See attached that correspondence attached as "L". But, as illustrated in the February 2024 email he did not, only providing the 2023 year end donations at that time. I am assured by the Treasurer that this was an honest mistake.

The Candidate Return was populated by the National Party, based on information my Electorate Treasurer sent to National HQ. Due to time restraints the final return was not reviewed properly by the New Plymouth Electorate team or myself as to why there was only 2023-year information in the Return. I relied on the Treasurer to complete the return template correctly and therefore assumed the draft Candidate Return sent to me by the National Party was also correct. I also assumed that because 2022 donations had been disclosed to the National Party they must have already been disclosed to the Electoral Commission. I was mistaken.

I never intended to not disclose these donations and I apologise for the error I made.

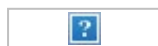

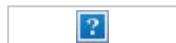

**REFERRAL OF ALLEGED BREACH OF SECTION 209B OF THE ELECTORAL ACT 1993 – DAVID MACLEOD
CANDIDATE DONATIONS**

This letter refers David MacLeod, National Party candidate and Member of Parliament for New Plymouth to Police for an apparent breach the Electoral Act 1993 (the Act) for failure to report \$178,394 of candidate donations in his candidate return for the 2023 General Election.

David Macleod was selected as the National Party candidate for the New Plymouth electorate and he began campaigning in late 2022. His campaign was successful, and he is currently the electorate MP for New Plymouth.

The Commission received David McLeod’s candidate return on 13 February 2024. The total donations disclosed were \$29,268 from seven separate donors. This return is attached as **Appendix A**. Candidate returns were published on the Commission’s website on 22 February 2024.

On 20 May 2024, the Commission received an amended candidate return from David McLeod. The total donations disclosed in the amended return are \$207,662 from 24 separate donors. This return is attached as **Appendix B**. The total amount of previously undeclared donations is \$178,394. This return has been published by the Commission on elections.nz, replacing the original return.

The amended return reports nineteen donations from November and December 2022 (including aggregations) and one donation on 19 June 2023 that were not included in his original return. Two donors in the original return have had additional amounts from 2022 added and one has had a name change from Waume Tilo to Wayne Tuki.

David MacLeod has provided a letter of explanation which is attached as **Appendix C**. In summary, he states that the omission of the donations was inadvertent because he mistakenly believed only donations that he received in 2023 were to be included in his candidate return. He mistakenly believed his 2022 donations had been disclosed to the National Party and that his candidate return

for the 2023 General Election was correct. This error was identified on 13 May 2024. His subsequent audit of donations identified a further donation of \$10,000 received in 2023 which was not reported in the original return as it had been omitted from the information provided by the candidate's team to the National Party HQ when the return was prepared.

On 24 May 2024, the Commission sent a letter to David MacLeod which asked him to provide further details regarding the donations. The letter is attached as **Appendix D**.

On 30 May 2024, David MacLeod provided a response to the Commission's letter and also provided accompanying documents which are attached as **Appendix E**.

Electoral Act 1993 and Commission Guidance

Section 209B of the Act sets out the offences relating to the return of candidate donations. In relation to David MacLeod's non-disclosure of donations in his first candidate return, [section 209B\(2\)](#) states:

(2) A candidate who files a return under section 209 that is false in any material particular is guilty of—

(a) a corrupt practice if he or she filed the return knowing it to be false in any material particular; or

(b) an illegal practice in any other case unless the candidate proves that—

(i) he or she had no intention to misstate or conceal the facts; and

(ii) he or she took all reasonable steps in the circumstances to ensure that the information in the return was accurate.

[Section 207M](#) of the Act requires candidates to keep proper records of all candidate donations received. A candidate who fails, without reasonable excuse, to comply with this requirement is liable on conviction to a fine not exceeding \$40,000.

The Commission published the [Candidate Handbook](#) (Handbook) in January 2023 which was circulated to all candidates for the election. The Handbook provided detailed guidance on candidate donations and how they should be recorded and reported. In particular, the Handbook states:

The donations rules apply to any donations given for your campaign, from the point you start fundraising or seeking donations. The rules are not limited to election year or the regulated period.

Candidates could also obtain information regarding donations on the Commission's [Candidate Hub](#), where the Handbook was also available.

The instructions for Part A of the 2023 General Election candidate return form, where the donations were reported by David MacLeod, included a worked example showing that disclosure of donations received in previous years is required.

The return form includes a declaration the candidate signs that the return is *“an accurate record of the candidate donations made to me, or on by behalf... for my campaign for the 2023 general election and is not false in any material particular”*.

Alleged breach of section 209B of the Electoral Act 1993

The return received on 13 February 2024 was false in a material particular. It did not include \$178,394 in candidate donations.

David MacLeod says that he did not knowingly file a return that was false (the undeclared donations) and had no intention to misstate or conceal the facts. Rather, he says that there was a misunderstanding of both the donation disclosure requirements, and issues regarding the way records were kept and used to prepare the return that he approved.

Under section 209B(2)(b), it is still an illegal practice offence to file a return that is false in a material particular unless the candidate proves that they had no intention to misstate or conceal the facts and they took all reasonable steps in the circumstances to ensure that the information in the return was accurate. This is a reverse onus offence, so it is up to the candidate to prove that they took all reasonable steps.

David MacLeod's letters note that he had no intention of concealing the donations and points out that he wrote to all donors advising them that all donations to him over \$1,500 would be publicly disclosed. He states that in November 2022, his electorate team included most of the donations in a financial reporting template that was provided to National Party Headquarters. In addition, once he became aware of the issue (via the National Party), he conducted a full audit of his candidate return, proactively advised the Commission and provided an amended return.

He further asserts in his letter dated 30 May 2024 that the non-reporting of the donations was inadvertent due to the inexperience of his treasurer and the National Party's changes in reporting systems regarding candidate donations.

However, the question remains as to whether David MacLeod took 'all reasonable steps in the circumstances to ensure that the information in the return was accurate'. Factors you may wish to consider include:

- The number and value of the undeclared donations is significant.
- There is clear guidance in the Handbook and in Part A of the return form regarding recording and reporting of all candidate donations received for a candidate's campaign, including a specific example showing that disclosure of donations prior to 2023 is required.
- While David MacLeod may have misunderstood the internal reporting processes between himself and the party, it was his responsibility to ensure his candidate return is accurate and includes all donations and it is difficult to see how he has taken reasonable steps given the clear guidance available.
- While the treasurer may have been inexperienced and may have misunderstood the reporting requirements, the candidate is ultimately responsible for their candidate return.
- The National Party altered their internal process for candidates reporting donations to the party in 2023. However, it appears that no other National Party candidate had similar difficulties that resulted in the non-reporting of donations.

There is a high level of public interest in donations over \$1,500 received by candidates. The Commission has not had similar levels or types of non-disclosure by candidates of donations previously.

Under the Act, the Commission is required to refer any breach of section 209B of the Act to Police unless the Commission considers that the offence is so inconsequential that there is no public interest in reporting those facts to Police ([section 204O](#)). Inconsequential means ‘not important or significant’ and ‘of no consequence’.

Given the number and total value of the donations omitted from the original return, the Commission does not consider the offence is so inconsequential that there is no public interest in reporting these facts to Police.

A prosecution against a person for an illegal practice must be commenced within 6 months of the date on which the prosecutor is satisfied that there is sufficient evidence to warrant the commencement of the proceedings but not later than 3 years after the illegal practice was committed ([section 226\(2\)](#) of the Act).
