

FAQs on Māori wards for enquiries teams

Background

A recent law change means some local councils are reviewing their arrangements for Māori wards or constituencies.

The Local Government (Electoral Legislation and Māori wards and Māori Constituencies) Amendment Bill was passed on 30 July 2024.

Councils that established a Māori ward after 2021 without polling ratepayers will have to either hold a poll with the 2025 local elections or disestablish the ward. 45 councils are affected.

What is the Electoral Commission's role in this?

The Electoral Commission is not involved in running or overseeing local body elections or reviewing local body boundaries. We are not involved in decisions on local wards.

Our role in local elections is to keep the electoral rolls up to date and provide councils with electoral roll data when they hold their elections.

I'm on the Māori roll. Which ward will I vote in at the local elections?

If you are on the Māori roll and your local council has a Māori ward or constituency at the time of the 2025 local elections, you will vote for candidates in that ward or constituency.

If you are on the Māori roll and your council does not have a Māori ward or constituency, you will vote in the ward you live in.

I'm on the general roll. Which ward will I vote in?

If you are on the general roll, you will vote for candidates in the general ward you live in.

Can I change rolls?

If you're Māori, you can change rolls at any time except in the three months before a general election or the local elections. You can change from the Māori roll to the general roll, or from the general roll to the Māori roll.

Early next year, the Electoral Commission will write to enrolled voters who have identified themselves as Māori to let them know the deadline for changing rolls before the 2025 local elections.

The LGNZ and the LGNZ and Taituarā websites are the only websites where you can find a full list of councils and their contact details.

We have included links to the votelocal.co.nz website in previous local elections because it is helpful for voters, especially in the early stages of the local elections when there is not much information available from councils. People often don't know which council area they are in or how to contact their council.

We received a complaint from one member of the public in August. We felt making the information on councils and their contact details easily accessible was important, so we kept the links up at that point.

Now it's been raised again, we have reconsidered and have erred on the side of caution and removed the links. People wanting information on the local elections will need to contact their council or check their voting pack.

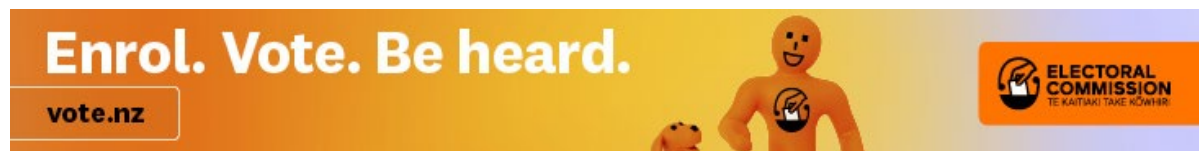

This is a scandal. While Hobson's Pledge advertisements are shut down, while our supporters are harassed, while the media churns out hit piece after hit piece against us – another pro-māori wards group is given a megaphone by the Electoral Commission itself.

That lobby group is LGNZ. And let's be clear: LGNZ is nothing more than a lobby group like any other. It represents councillors who choose to pay their membership fees – not the people of New Zealand. Yet while our voices are silenced, their website is linked directly from the Commission's own website on Māori Wards.

This shocking development was brought to light by [ACT MP Cameron Luxton, who revealed that](#) the Electoral Commission's own website linked directly to an LGNZ page pushing Māori wards as "a good for democracy." The page carried no disclaimer that it was not endorsed by the Commission. Worse, it was dressed up in the Commission's own orange branding and stamped with "Vote 2025," making it look like official electoral advice rather than lobbyist propaganda.



And now, within just 24 hours of Cameron Luxton releasing his video, the Electoral Commission has quietly scrubbed the link from its website. They know they've been caught out.

Let's be clear: if the Electoral Commission can't be trusted to stay impartial, then the very foundation of our democracy is under threat.

New Zealanders deserve a fair debate and a fair vote - not interference from a government body meant to be impartial. That's why Hobson's Pledge has fired off the following legal letter demanding an immediate stop to this disgraceful behaviour:

Re: Assurance of impartiality in Māori wards referenda and review of Commission communications

I write on behalf of Hobson's Pledge to seek immediate reassurance from the Electoral Commission that it is acting with complete neutrality and fairness in relation to the current Māori wards referenda being held across New Zealand.

It has come to public attention, via MP Cameron Luxton, that material promoting Māori wards appeared on the Commission's website during a period in which many local authorities are conducting referenda on the matter (see link: <https://x.com/actparty/status/1973612028486099190>). We note and appreciate that the content appears to have since been removed. However, the episode raises serious concerns about how such material came to be published, and whether similar content remains in circulation elsewhere.

Background and concerns

The Electoral Commission's credibility rests upon its absolute impartiality. Even the perception of bias risks undermining confidence in the fairness of the democratic process, particularly when New Zealanders are being asked to vote on sensitive questions of representation and governance.

Section 11 of the Electoral Act 1993 and long-standing principles of administrative neutrality require the Commission not only to act impartially but also to be seen to do so. In this case, the publication of content appearing to favour one outcome of the Māori wards referenda is deeply troubling.

To restore confidence and ensure transparency, we respectfully request the following:

1. **Public assurance of neutrality:** *That the Electoral Commission confirm in writing that it is, and will continue to be, entirely neutral in all communications and actions relating to Māori wards and the associated referenda.*
2. **Confirmation of removal:** *That the Commission confirm all promotional or potentially biased material, including website pages, public statements, and social media posts, has been fully removed or corrected.*
3. **Independent review:** *That the Commission undertake (or permit) an independent review of its communications, content approval processes, and oversight mechanisms.*
4. **Accountability and prevention:** *That the Commission outline what accountability measures or internal processes are being taken to identify how the breach occurred, and what steps are being implemented to prevent a recurrence.*
5. **Disclosure of relevant guidance:** *That the Commission disclose any internal guidance, policy, or correspondence relating to Māori wards or local representation that informed its public communications.*

Hobson's Pledge seeks a fair, balanced, and transparent process. Public confidence in the Commission depends on visible accountability when errors occur. We trust that you will treat this matter with the seriousness it deserves and provide the requested assurances without delay.

We look forward to your written response.

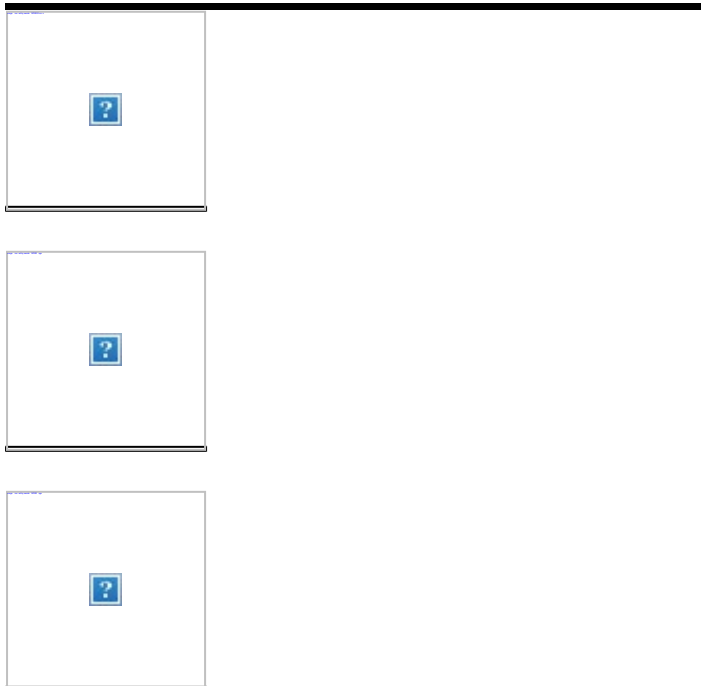

ACT forces Electoral Commission to remove link to pro-Māori Wards messaging

ACT Local Government spokesperson Cameron Luxton is welcoming the Electoral Commission's decision to remove a partisan link from its website after pressure from ACT, but says questions remain about why it was ever there, and why public concerns were brushed off until after voting had already begun.

Luxton wrote to the Auditor-General on Monday about this issue, and has raised concerns via ACT's social media channels.

"The Electoral Commission has finally done the right thing by removing the link on it's official website to one run by lobby group Local Government New Zealand's (LGNZ) that promotes pro-Māori wards messages. But it should never have been there in the first place," says Mr Luxton.

"LGNZ is a political lobby group that campaigns on political issues, including against the public's right to have a say on Māori wards.

"The LGNZ page wasn't neutral information. It argued in favour of Māori wards, saying: 'Establishing Māori wards and constituencies provides an inclusive and democratic avenue for councils to collaborate with Māori, fostering positive relationships and ensuring decisions benefit the entire community.' That is a political judgment, not a factual explanation. Others can make those arguments if they wish, but it is not the role of the Electoral Commission to do so, directly or by proxy.

"Worse, the LGNZ page uses colours and branding similar to the Commission's own, and its domain name [votelocal.co.nz](#) closely resembles the Commission's [vote.nz](#). Voters clicking through from the Commission's website could easily be forgiven for thinking they're still on the official Electoral Commission page.

"What's most concerning is that a member of the public raised this issue with the Commission before voting opened – and was dismissed. The Commission said it wasn't responsible for the content of other websites, missing the obvious point that it was choosing to link to partisan material. Those concerns were left unanswered for weeks while voting was already underway.

"This raises serious questions. Why did it take outside pressure for the Commission to act? Why were earlier warnings ignored? How did such a basic breach of neutrality happen in the first place?

"That's why I've called on the Auditor-General not only to review the Commission's actions, but to conduct a wider inquiry to ensure this can never happen again.

"The integrity of our democracy depends on an impartial referee. The Commission must be beyond reproach – and right now, the public needs assurance that this was a one-off mistake, not a sign of deeper problems."

Local councils run the local elections

Local elections are run by local councils. Each local authority appoints an electoral officer to conduct its election.

If you are enrolled by 1 August, your local council will send you voting papers in the mail when it's time to vote.

The Electoral Commission's role is to make sure each council has up-to-date electoral roll information in time for the elections. We do not run or oversee the local elections.

In local elections, we choose who represents us on our councils. Local elections are run by local councils and are held every 3 years by postal vote. If you're on the electoral roll, you can vote in local elections where you live.

Local elections decide who has a say on local elections

Local elections decide who represents our local communities on local issues. Local elections are held for city, district, and regional councils.

In some parts of New Zealand, local elections are also held for local and community boards, licensing trusts, and some other organisations.

Local councils run local elections

Local councils do most of the work of running local elections. Our role is to:

- make sure each council has an up-to-date electoral roll in time for elections
- encourage people to enrol in time to vote.

If you're enrolled, your local council will send you voting papers in the mail.

Voting when you're on the unpublished roll

If you're registered on the unpublished roll, you need to apply to the electoral officer at your local council to get your voting papers.

Voting from overseas

If you're overseas, you can still take part in local elections. Just make sure you're correctly enrolled with an overseas postal address to get your voting papers. You can't download voting papers for a local election.

Voting when you own property in a council area but don't live there

If you own property within a local council area, but usually live outside this area, you can apply to go on the ratepayer roll. You can then vote in the area where you pay rates, and the area where you live.

Apply to get on the ratepayer roll

To apply, contact the electoral officer for the local council area where you pay rates but do not live. The electoral officer will send you a form to complete, sign and return so they can check you're eligible.

General or Māori roll?

The roll you are on may affect the way you vote in local elections.

If you choose the Māori roll, and your local council has a Māori ward or constituency, you will vote for candidates in the Māori ward or constituency. If you choose the general roll, you will vote for candidates in the general ward or constituency.

When can you choose rolls?

If you are Māori, and enrolling to vote for the first time, you choose which electoral roll you want to be on.

You can also change your roll type at any time, except:

- in the 3 months before a general election
- in the 3 months before local elections which are held every 3 years
- before a parliamentary by-election if the change would move you into the electorate where the by-election is being held.

If you're Māori and enrolling for the first time you can still choose either the Māori roll or the general roll.

We're responsible for making sure everyone follows the rules about promoter statements, authorisation of advertising and electoral finance.

You can complain to us about breaches of:

- election advertising and the election day rules under the Electoral Act
- requirements for election **programmes** under the Broadcasting Act.

You can also ask us for advice about election and advertising rules.

If we believe a person or group has committed an offence, we'll report the facts to the police. We can't enforce laws or prosecute offenders.

Sometimes, we may not report an offence if there's no public interest because it's so inconsequential.

Our role does not include regulating the content of campaign advertising, broadcasts or media activity. The Broadcasting Standards Authority, the Advertising Standards Authority and the Media Council all have roles in regulating of content (see below).

If you want to put up election signs for the general election or a by-election you need to be aware of the rules.

Local councils regulate election signs in their area

You should talk to your local council before you put up any election signs. Local councils are responsible for regulating when, where, and how election signs can be displayed. There is no fixed date in the Electoral Act when election signs are allowed to go up. Election signs can go up as soon as they are allowed to be displayed in the area you live.

Election signs on or near state highways

Waka Kotahi must approve general election signs that will be placed on or next to state highways and signs must comply with the Waka Kotahi general election sign guidance. Further information is available [here](#).

What size election signs are allowed?

In the 9 weeks before election day the Electoral Act says you can have election signs that are up to 3 square metres in size. This supersedes any council rules about the size of election signs in this period.

This applies wherever you are in New Zealand, but you'll still need to follow your local council's application processes and rules about where you can put them up and how many you can have.

Total area = 3 square metres

This for example covers a standard billboard 1.2m x 2.4m.

It is not 3m² (metres squared) - which would be 3 x 3m and a total of 9 square metres.

Bigger signs can go up, and signs can go up sooner if the council allows this. Talk to your council if you want to have larger signs or put them up earlier.

The lettering of signs larger than 1.5 square metres that are on a road must be:

- 120mm in height if the speed limit is less than 70km per hour
- 160mm in height if the speed limit is more than 70km per hour

These requirements do not apply to lettering on registered party logos or promoter statements.

There are also rules that relate to road safety and the use of reflective material or illuminations, having moving parts or looking like traffic signs in the [Electoral \(Advertisements of a Specified Kind\) Regulations](#).

The rules in the Electoral Act

We are responsible for the rules in the Electoral Act.

These rules allow campaigning to start at any time, other than on election day.

Election signs need a promoter statement

If an election sign is an election advertisement it needs a promoter statement to be clearly displayed, with the name and address of the person that has instigated it. This rule provides transparency about who is responsible for election advertising.

Clearly displayed doesn't mean someone should be able to read the promoter statement from where the advertisement is ordinarily viewed. For example, people don't need to be able to read the promoter statement on a billboard while they're driving past. A person should be able to read the promoter statement if they stop to examine the billboard.

Getting written authorisation for candidate and party signs

You can only put up signs promoting a party or candidate with their prior written consent. This rule allows candidates and parties to decide who initiates advertising that encourages voters to vote for them. They also need to know about the cost of signs that are up in the three months before the general election as the cost of the signs that promote them count towards their expense limits.

You don't need written authorisation for advertising that encourages people not to vote for a candidate or party.

Paying someone to put up election signs

You can only pay someone to put up an election sign on their property, if displaying signs is part of their business.

This rule means people can't pay members of the public or businesses to put up signs on their land or property if they don't usually charge for this service.

The rules when voting starts

You can't display election signs within 10 metres of an advance voting place once voting starts.

All election signs need to be taken down or covered up by midnight on Friday, the day before election day.

You can't display election signs on election day.

Dear Mr Le Quesne,

Re: Assurance of impartiality in Māori wards referenda and review of Commission communications

I write on behalf of Hobson's Pledge to seek immediate reassurance from the Electoral Commission that it is acting with complete neutrality and fairness in relation to the current Māori wards referenda being held across New Zealand.

It has come to public attention, via MP Cameron Luxton, that material promoting Māori wards appeared on the Commission's website during a period in which many local authorities are conducting referenda on the matter (see link: <https://x.com/actparty/status/1973612028486099190>). We note and appreciate that the content appears to have since been removed. However, the episode raises serious concerns about how such material came to be published, and whether similar content remains in circulation elsewhere.

Background and concerns

The Electoral Commission's credibility rests upon its absolute impartiality. Even the perception of bias risks undermining confidence in the fairness of the democratic process, particularly when New Zealanders are being asked to vote on sensitive questions of representation and governance. Section 11 of the *Electoral Act 1993* and long-standing principles of administrative neutrality require the Commission not only to act impartially but also to be seen to do so. In this case, the publication of content appearing to favour one outcome of the Māori wards referenda is deeply troubling.

To restore confidence and ensure transparency, we respectfully request the following:

1. **Public assurance of neutrality:** That the Electoral Commission confirm in writing that it is, and will continue to be, entirely neutral in all communications and actions relating to Māori wards and the associated referenda.
2. **Confirmation of removal:** That the Commission confirm all promotional or potentially biased material, including website pages, public statements, and social media posts, has been fully removed or corrected.
3. **Independent review:** That the Commission undertake (or permit) an independent review of its communications, content approval processes, and oversight mechanisms.

4. **Accountability and prevention:** That the Commission outline what accountability measures or internal processes are being taken to identify how the breach occurred, and what steps are being implemented to prevent a recurrence.
5. **Disclosure of relevant guidance:** That the Commission disclose any internal guidance, policy, or correspondence relating to Māori wards or local representation that informed its public communications.

Hobson's Pledge seeks a fair, balanced, and transparent process. Public confidence in the Commission depends on visible accountability when errors occur. We trust that you will treat this matter with the seriousness it deserves and provide the requested assurances without delay.

Thank you for your letter of 3 October 2025.

The Electoral Commission is an independent Crown entity responsible for impartially administering the parliamentary electoral system in accordance with the Electoral Act 1993.

We take any complaints about our impartiality seriously.

For each electoral event we consider carefully what information we provide, including links to external information with a view to assisting electors and being impartial.

The Commission does not run or oversee local elections. Our role is to make sure people are enrolled to vote and provide each council with up-to-date roll information. We provide information [on our website](#) about how and when to enrol for the local elections.

We receive a lot of questions from members of the public about the local elections that need to be directed to local councils, who are responsible for local elections and referendums.

To make it easier for people to contact their council for more information, we provided a number of links to www.votelocal.co.nz/ and [Council websites and maps - LGNZ](#). It is clear by the way we link to content that it goes to external sites.

We have taken the same approach for previous local elections. We have also taken this approach for the information we provide on parliamentary elections to parties, candidates, third party promoters and the public, including on how to contact councils about their rules for when and where electoral signs in their area can go up for parliamentary elections.

In response to the concerns you have raised, we note we have not published any content that has promoted how voters should vote in referendums on the Māori wards and constituencies being held as part of the local elections.

Our websites link to a number of different external websites, including some websites containing political content, for example, the [Register of Political Parties](#) includes links to party websites. In our view this does not compromise the impartiality and neutrality of the Commission.

Prior to Cameron Luxton's post on X on Thursday 2 October, the Commission received one complaint on 27 August about the link from vote.nz to [About Māori wards and constituencies - Vote 25 | Pōti 25](#).

In response to that complaint, we explained that to help voters who may come to us to seek information about the local elections, we provided links to votelocal.co.nz, a website maintained by Local Government New Zealand and Taituarā - Local Government Professionals Aotearoa. This website includes detailed information about the local elections and is a single site where electors can find contact information for every council's electoral officer and information on all of the councils that are holding polls on Māori wards.

We encouraged the complainant, if they had concerns about the content provided by votelocal.co.nz, to contact the administrators of that website.

Erring on the side of caution, following the second complaint made by Cameron Luxton last week, we have removed the specific link that was complained about. We have also removed links to the vote local and LGNZ websites from the page content of vote.nz and elections.nz.

I have looked into the way the original complaint was handled and have considered the public interest in finding accessible information on local elections. I am satisfied that there was no intent to influence the debate on Māori wards.

To assist voters we have published [a list](#) of local councils and their electoral officer contact details. This way electors can find this information if they come to the vote.nz website, and our enquiries and community teams can also point voters to their local council to, for example, arrange special votes.

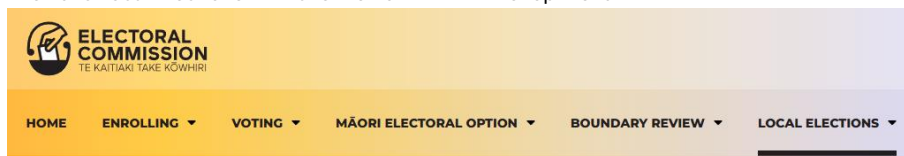

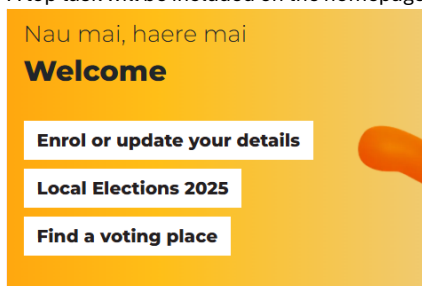

How to change your roll

If you would like to change your roll type in time for the local elections, you need to do so by **midnight, Thursday 10 July**. You can't change rolls in the three months before the local elections.

You can change your roll by completing and returning the form in your enrolment update pack. You can also change your roll online, or by completing and returning a printed enrolment form.

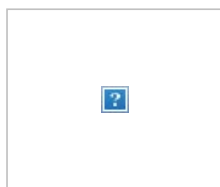

We have had a small number of complaints about the links. Erring on the side of caution, we have taken the links down.

The Electoral Commission does not run or oversee local elections. They receive a lot of questions about the local elections that they can't answer, so to make it easier for people to access information about the elections, they provided links to external sites with lists of council websites and maps, contact details for electoral officers, and a list of councils holding polls. They have taken those links down. People wanting information on the local elections should contact their local council or check their voting papers.

Should the Electoral Commission provide information on Māori ward polls?

The Electoral Commission does not run or oversee local elections, so they don't provide information on the conduct of the elections or polls on their own website.

Additional background for stakeholders

The LGNZ and the LGNZ and Taituarā websites are the only websites where you can find a full list of councils and their contact details.

We have included links to the votelocal.co.nz website in previous local elections because it is helpful for voters, especially in the early stages of the local elections when there is not much information available from councils. People often don't know which council area they are in or how to contact their council.

We received a complaint from one member of the public in August. We felt making the information on councils and their contact details easily accessible was important, so we kept the links up at that point.

Now it's been raised again, we have reconsidered and have erred on the side of caution and removed the links. People wanting information on the local elections will need to contact their council or check their voting pack.

Establishing Māori wards and constituencies provides an inclusive and democratic avenue for councils to collaborate with Māori, fostering positive relationships and ensuring decisions benefit the entire community.

- *Does the Minister think it is acceptable for the EC to link to materials that appear to be attempting to influence voters?*
- *Does the Minister expect the EC provide its own guidance on the Maori ward vote, instead of relying on outside sites?*
