OFFICIAL INFORMATION ACT REQUEST 2025/14

On Thursday 6 March 2025, you made the following request under the Official Information Act 1982 (the OIA):

"Regarding the number of referrals made by the Electoral Commission to the police over the past ten years. Specifically, I would like to request the following information:

- The total number of referrals made by the Electoral Commission to the police in the last ten years
- 2. For each referral, a brief description of the nature of the alleged offence(s), including the political party or parties involved, if applicable.
- 3. Any available statistics on the outcomes of these referrals, including whether they led to a prosecution or any other action being taken.

If the requested information cannot be provided in full, I would appreciate it if you could provide the information that is available, and if relevant, explain any limitations or reasons why certain details cannot be disclosed."

The aspect of question 3 of relating to prosecution outcomes has been transferred to the Ministry of Justice as prosecution is a courts function. The other aspects of question 3, relating to other actions taken after a matter is referred to Police, has been transferred to Police. The Commission does not have the power to impose other sanctions so outcomes are for Police to comment on.

By way of response, we set out below in a table all matters the Commission has referred to Police from 2015-2025, along with a description of the matter. The number of matters in the table below is 56, but each may relate to a number of individuals or apparent breaches.

You may be aware from previous OIA responses and our public statements that we publicly name political parties where we refer matters to Police, but we do not name individuals unless this is already in the public domain.
