Mt Albert By-Election - Questions and Answers

Voting

1. Who can vote in the Mt Albert by-election?

Only people enrolled in the Mt Albert electorate can vote in the by-election. They must be enrolled to vote by Friday 12 June - the day before election day.

2. Where can people vote?

On election day people can vote at one of the polling places within the Mt Albert electorate boundaries. Where possible the polling places for the 2008 General Election will be used. There will be no polling places outside the Mt Albert electorate on election day.

People who can't vote in the electorate on election day can vote in advance at an advance voting place in the electorate or at any Registrar of Electors office around the country.

People overseas can vote in person at the:

3. When can people vote?

Polling places in the Mt Albert electorate are open from 9.00am to 7.00pm on election day, Saturday 13 June.

People who need to vote in advance, those going overseas or those overseas already can vote from Wednesday 27 May.

4. Where will the polling places be?

The number of polling places inside the Mt Albert electorate and their locations are being finalised now. Where possible the polling place locations used in Mt Albert for the 2008 General Election will be used for the 13 June by-election

The polling places will be in locations such as school and community halls.

5. How many polling places will there be?

We expect there will be around 28 polling places in the electorate.

6. Will there be an EasyVote pack?

Yes. Voter information packs will be sent during the week before election day to everyone who was enrolled by Monday 11 May. These packs will include

- the candidates for the Mt Albert by-election
- advance voting facilities and
- the polling places for the Mt Albert electorate.

The packs will also include a personalised *EasyVote* card. This will have

- the person's name,
- their address, and
- the page and line number they appear on the Mt Albert electoral roll.

7. What if a person doesn't get an EasyVote card, can they still vote?

Yes. The EasyVote card has been designed to make the voting process easier, but people can vote without it.

8. Will there be a party vote and an electorate vote?

The by-election is to elect a new Member of Parliament for the Mt Albert electorate.

There is only one vote in the by-election, the vote for the electorate candidate.

9. Where do voters find out information about where, when and how to vote?

Information on where, when and how to vote is contained in the EasyVote pack. Information is also available from www.elections.org.nz or 0800 36 76 56. Copies of brochures are also available by calling the 0800 number or emailing vote@elections.org.nz.

VOTING – BEFORE SATURDAY 13 JUNE

10. What do people do if they are not in the Mt Albert electorate on Saturday 13 June?

People can vote in advance from Wednesday 27 May either in the electorate, or at any Registrar of Electors office around the country.

11. Will people be able to vote outside their electorate on election day?

No. Voting facilities will only be available in the electorate on election day. If someone is outside their electorate on Saturday 13 June they will have to vote in advance.

12. What do people do if they are overseas on Saturday 13 June?

There are four ways people going overseas can vote:

1. make an advance vote before leaving New Zealand from Wednesday 27 May.
2. download voting papers from the internet: www.elections.org.nz
3. apply for postal voting papers
4. vote in person at an overseas post:

- The amount candidates can incur in election expenses in the three months before the by-election day is limited to \$40,000 (inc GST)
- Candidates (or their agent) must give written authorisation before any advertisement promoting their election can be published.
- The advertisement must state the name and business or residential address of the person directing it to be published.
- Campaigning is forbidden on the day of the by-election.

4. What are the rules relating to donations?

Candidate donations and contributions to donations of \$1,000 or more must be declared. Candidates are not allowed to keep anonymous or overseas donations of more than \$1,000.

5. Are there limits on how much can be spent on campaigning?

Yes. A maximum of \$40,000 (including gst).

6. Are there broadcasting allocations?

There are no broadcasting allocations. These only apply to party campaigning.

7. Are candidate's required to appoint a financial agent?

No. This is no longer a requirement.
